He was over forty when he left St. Agnes for Bunmahon about 1837 along with his wife and at least four children aged eleven to one year. At least four more children were born during his stay here. In 1852, aged 57, he made the dramatic decision to move his family to Australia. He spent the rest of his life at

Kapunda mine in south Australia and at least one child was born there. His wife died in 1863 and William in

#### **CELTIC COPPER HERITAGE**

Celtic Copper Heritage is a three partner project which involves collaborative work on the Avoca Mines (Ireland) and Parys Mountain Mines (Anglesey, North Wales). The project is funded under the InterReg IIIA programme of the European Union and is lead by the Eastern Regional Fisheries Board (Ireland) and the Amlwch Industrial Heritage Trust ('AIHT') Ymddiriedolaeth Ddiwydiannol Amlwch (Wales).

The aim of 'Celtic Copper Heritage' (in both Ireland and Wales) is "to harness the historical copper mining heritage in both areas as a means of generating positive economic, social, cultural, and environmental impacts in deprived rural communities".

To ensure this aim is achieved, the associated objectives of 'Celtic Copper Heritage' are to:

- Develop new educational and research facilities/ opportunities;
- Conserve and preserve the internationally important industrial heritage;
- Raise the profiles of Amlwch and Avoca as visitor destinations;
- Enhance and protect the natural rivers at both locations;
- Facilitate the transfer and sharing of expertise and knowledge; and
- Develop further partnership and working arrangements between both applicant organisations.

Common features of the two mine areas, which creates the basis for collaboration through the 'Celtic Copper Heritage' project can be summarised as:

- Similar ore deposits and associated 200 years of mining history;
- Comparable geology with the host rocks being 'Lower Palaeozoic' in age and comprising of volcano-sedimentary piles;
- Development of both mines was started in the late 18<sup>th</sup> century by the same company which transferred from Amlwch, at the end of its lease, to Avoca;
- Pollution poses problems at both sites in the form of 'acid mine drainage' ('AMD'), thus inhibiting future development planning.

Joint areas for collaboration, facilitated through the 'Celtic Copper Heritage' project, and the associated positive outcomes are:

 Joint working initiatives to reduce the adverse environmental impacts of abandoned metal mines;

- Enhanced marketing of both natural visitor attractions to raise overall visitor numbers and generate enhanced economic benefits;
- Improved interpretation and understanding of the two areas' history and heritage amongst the local populations;
- Adding value and raising the quality of historical local features and the natural environment as drivers for rural development;
- Stimulate interest and opportunities for local people to develop associated businesses to exploit the history, heritage, and generate economic benefits;
- Greater utilisation of both sites for educational purposes (as part of the National Curriculum and Further/Higher education).

The Mining Heritage Trust of Ireland is a partner in this project. Activities to date include

- 1. Commissioning of pilot plant at Avoca to treat water from two adits (Jan-April 2006)
- 2. Appointment of full-time manager (Wales) and parttime co-ordinator (Ireland) 3. Partner and public meetings
- 4. Development of a web site
